<b>ALLOCATION OF QUALIFICATION</b>	The qualification is allocated to the NPC not the individual athlete or team.
<b>MAXIMUM QUOTA ALLOCATION PER NPC</b>	<p>An NPC can be allocated a maximum of three (3) qualification slots per sport class for a maximum quota allocation of twelve (12) qualification slots per gender per NPC. The maximum qualification slots to be allocated per sport class is as follows:</p> <ul style="list-style-type: none"> <li>• twelve (12) qualification slots for the men's Individual Compound - W1</li> <li>• thirty-two (32) qualification slots for the men's Individual Recurve - W1/2</li> <li>• twenty (20) qualification slots for the women's Individual Recurve - W1/W2</li> <li>• twenty (20) qualification slots for the women's Individual Recurve - Standing</li> <li>• eight (8) qualification slots for the women's Individual Compound - Open</li> <li>• twenty-Four (24) qualification slots for the men's Individual Recurve - Standing</li> <li>• twenty (20) qualification slots for the men's Individual Compound - Open</li> </ul>

(Athletes for the team event are selected from those who have competed in the individual events.)</p>

<b>IPC OUTDOOR ARCHERY WORLD RANKING ALLOCATION</b>	<p>The IPC Outdoor Archery World Ranking List starting 1 January 2007 and closing 30 January 2008 will be used to allocate the remaining qualification slots in each sport class as follows:</p> <p>Step I - All athletes who have otherwise attained a qualification slot for their NPC will be removed.</p> <p>Step II - Starting with the top ranked athlete from the remainder, qualification slots will be allocated to each NPC in rank order until either the maximum class quota has been reached or the athlete's qualifying score is below the MQS.</p> <p>In the W1/W2 and Compound Open sport classes, the last four (4) slots will be allocated to athletes at the discretion of IPC Archery.</p>	<p>54 male athletes</p> <p>24 female athletes</p>

14 February 2008	Final date for NPCs to submit scores for the World Ranking List
21 March 2008 (no later than)	IPC Archery confirms in writing to NPCs the allocation of qualification slots



4 April 2008 (no later than)	NPCs confirm in writing to IPC Archery the use of allocated qualification slots
25 April 2008 (no later than)	IPC Archery confirms in writing the reallocation of unused team qualification slots
2 May 2008	Deadline for Beijing 2008 Organizing Committee to receive accreditation application forms submitted by NPCs
7 July 2008	Deadline for Beijing 2008 Organizing Committee to receive entry forms submitted by NPCs

### **DATES / PROCESS OF CONFIRMATION OF QUALIFICATION SLOTS**

By 4 April 2008, each NPC must confirm to IPC Archery in writing (fax and e-mail are accepted) the number of qualification slots they will use. NPCs that have not replied by this date will have lost their qualification slots, and IPC Archery may reallocate these slots.

By 25 April 2008, IPC Archery will confirm in writing the reallocation of all unused qualification slots.

By 26 April 2008, it is officially declared that the respective NPC's will use the allocated quota granted for the Beijing 2008 Paralympic Games. Any NPC that does not use some or all of the qualification slots allocated may be subject to sanctions by the IPC.

### **REALLOCATION OF UNUSED QUALIFICATION SLOTS**

#### ***Slots allocated at the 2007 IPC Archery World Championships***

Any qualification slots earned in either the team or individual qualification methods at the 2007 IPC Archery World Championships and not used by the respective NPC will be reallocated to the NPC of the next highest ranked unqualified athlete(s) from this competition.

#### ***Slots allocated to Host Country***

Any qualification slots allocated to the Host Country that are not used will be reallocated through the IPC Outdoor Archery World Ranking Method to the NPC of the next highest ranked unqualified athlete from the respective sport class. If the next highest ranked athlete's score is below the MQS, the available qualification slot will be reallocated at the discretion of IPC Archery.

#### ***Slots allocated from World Ranking***

Any qualification slots earned from the IPC Outdoor Archery World Ranking Allocation Method that are not used by the respective NPC will be reallocated to the NPC of the next highest ranked unqualified athlete from the respective sport class. If the next highest ranked athlete's score is below the MQS, the



available qualification slot will be reallocated at the discretion of IPC Archery taking into account universality.
